## **Viewing Account Inquiry**



### **View Account Inquiry**


1. Click the Account Inquiry link to view your student's detailed account information.

2. Click the Return to Parent Center link (bottom left) when you are finished viewing.




3. Click Account Summary By Term to view the account information displayed by term.


