SUBJECT: Enrollment Report, Spring, 1989

You will find attached the on-campus report of official enrollment for Spring, 1989. Also attached is a copy of the standard enrollment report prepared by this office each semester which provides key data and comparisons with Spring, 1988. The total headcount has increased from a year ago by 3.14 % (399 individuals). {Spring, 1988 compared to Spring, 1987 showed a decrease of 295, 2.3%, individuals.}

A careful examination of the enrollment data is needed in order to ascertain shifts of enrollment which may be noteworthy and indicative of trends since my preliminary review of the data seems to indicate that the increase of enrollment is widespread among virtually categories of students. As highlights are gleaned, I will provide further information to you.
